

Publishing Process

Publishing process adopted by the Editorial Board of the journal "ANNALS OF THE UNIVERSITY OF ORADEA. Fascicle of Management and Technological Engineering ", requires that all manuscripts submitted for evaluation, peer-review and publication, unconditionally, meet all requirements provided on Journal's website, menu [Guide for Authors](#), so that they can be classified as scientific articles, after peer review process passed, in the form and type accepted by the Journal, such as: *Articles / Scientific Original Papers; Notes / Short Reports; Communications; Reviews; Comments; Research Letter; Editorials; Letter to The Editor.*

The journal "ANNALS OF THE UNIVERSITY OF ORADEA. Fascicle of Management and Technological Engineering" is based on a system of evaluation and peer-review of "simple blind " type: the scientific reviewers nominated for evaluating texts, know the identity of the authors and the institution of provenience, however the authors do not know the identity and reviewers affiliation.

Scientific papers accepted for publication, are published online in the system "Open Access", the authors of manuscripts being charged by a modest publication fee. The charge, for publication reasons is established at: 25EUR. There is no charge for subscription for university libraries, and research institutions. We offer discounts for authors who are **living in developing countries**, <http://data.worldbank.org/income-level/LIC>. Authors resident in these countries may apply to receive up to a 100% waiver of the standard publication processing fee. If an author is living in a developing country and need to apply for a waiver he/she should sent an email to the Editor-in-Chief (grebe@uoradea.ro; ggrebenisan@gmail.com) with the following information before submitting manuscript:author name and institution with full address details,the title of manuscript, country of residence of any co-authors.

Our expenses are due to: editing costs; costs of production and the electronic systematization; also costs due to the implementation and operation of the journal system; costs of manuscripts management, manuscripts archival; additional administrative costs. The journal's financial management should cover the costs of publication of accepted manuscripts and also the costs of all manuscripts reviewing, those accepted and those rejected too.

The journal "ANNALS OF THE UNIVERSITY OF ORADEA. Fascicle of Management and Technological Engineering", relies on a positive, proven editorial practice of leading scientific journals, namely, that the manuscript authors and their institutions belonging respectively institutions together the international agencies that finance these research actions or publication of scientific articles, agree, and accepts payment of small fee for the processing and publication into the "Open Access" system, given the immediate benefits of the publication systems: low costs, quick and easy access, great exposure that increases citations frequency.

Like any scientific journal also the journal "ANNALS OF THE UNIVERSITY OF ORADEA. Fascicle of Management and Technological Engineering" considers that a manuscript becomes an published article only after being scientific validation by a group of scientific personalities in the field: i.e. following a peer-review organized process. The journal "ANNALS OF THE UNIVERSITY OF ORADEA. Fascicle of Management and Technological Engineering" has a simple blind system peer-review process, which verifies, also evaluates, the manuscripts quality, in order to be issued a recommendation, such as: acceptance, revision (minor or major) or rejection of manuscripts. Normally, a manuscript can pass through the stages of the peer-review process, once or several times, depending on the observations, comments also on the recommendations of independent reviewers. If a manuscript was recommended for minor or major revision, it will be,

certainly, resubmitted for review, to the same reviewers, or to new reviewers, noting that, in this case, the new reviewers will receive comments and observations of previous reviewer/s. Depending on the fluency of communication, peer-review process can take up to four weeks.

Review Process is a fundamental concept of the journal “ANNALS OF THE UNIVERSITY OF ORADEA. Fascicle of Management and Technological Engineering”. By implementing this process, the Journal ensures of appropriate quality of submitted articles, so that they can be considered worthy scientific, respectively they can be published into the journal pages. This process has, of course, also another quality, namely one of that can be seen slightly, the peer review process may evidentiates eventually attempts to plagiarism, falsification or fabrication data.

Now it may be concluded that the publishing process adopted by the Journal “ANNALS OF THE UNIVERSITY OF ORADEA. Fascicle of Management and Technological Engineering” consists of two phases: peer-review process, and other, respectively the preparation and publication of the reviewed manuscript itself. A manuscript which has been reviewed, is returned to the author for editing, amending and updating, required by the reviewers, also in order for correcting figures and images, formatting them in full compliance with the requirements and instructions provided in the instructions and Guide for Authors. When the editor-in- chief of the Journal believes that the manuscript complies with all requirements provided, the quality of content and format of the manuscript are corresponding with that requested, the editor-in-chief makes the decision of publication article. At this stage, the author is requested to provide proof of payment fee, respectively to send a document which states the copyright transfer, authorship statement, and other documents needed to ensure that the manuscript is in accordance with all ethical rules reported in the journal ethics Policy. After receiving these documents from the author / authors, editor- in- chief communicates to the author/ corresponding author (if the paper has multiple authors), the publication decision and nominates the issue containing article also approximate the appearance date. Effectively, when the article its published on the journal website, this is the ending of publication process, the author is entitled to report this fact in subsequent references.
